

ORDINANCE NO. 1992(3)

AN ORDINANCE RELATING TO THE USE OF THE HOPKINS COUNTY TRANSFER STATION BY SMALL VOLUME HAULERS.

WITNESSETH: That,

WHEREAS, the Hopkins County Landfill located in Barnsley, Kentucky, will close effective July 1, 1992. And

WHEREAS, there are certain small independant haulers who collect household garbage in Hopkins County. And

WHEREAS, the Hopkins County Non-Taxing Solid Waste Management (109) Board desires to establish a policy or procedure by which these small haulers may use a transfer station constructed by Hopkins County at the Barnsley location.

NOW THEREFORE, BE IT ORDAINED and established that:

Small volume waste haulers may use the Barnsley Transfer Station provided they meet the following conditions:

- (1) The trucks to be used by the small haulers must have a one (1) ton weight limit or less.
- (2) The waste hauled by the small waste haulers must be non-compacted.
- (3) The solid waste must be residential household waste only.
- (4) The small volume waste hauler must be in business as of July 2, 1992.
- (5) The small volume waste hauler shall be allowed to haul waste generated in Hopkins County only (no out of county

household waste shall be allowed to be dumped at the transfer station).

(6) Small volume hauling must be their principal source of income.

(7) The small volume hauler must have a permit renewed yearly, not to exceed 2 years.

(8) The small volume waste hauler must have a permit issued by the 109 Board prior to dumping waste at the Transfer Station.

BE IT FURTHER ORDAINED that this ordinance shall go into effect on August 1, 1992, and only those small volume waste haulers who have registered and obtained a permit issued by the 109 Board through the Hopkins County Judge/Executive shall be allowed to qualify for the use of the Hopkins County transfer station. (No applications shall be accepted by the 109 Board after August 1, 1992.)


BE IT FURTHER ORDAINED that the small volume waste haulers shall furnish the 109 Board a complete list of their customers including addresses as of the date of registration.

BE IT FURTHER ORDAINED that any small waste hauler who holds a valid permit to use the Hopkins County Transfer Station shall abide by all of the laws, regulations, ordinances, directives or other similar binding authority relating to solid waste or it's collection and disposal, and failure to abide by these terms shall result in forfeiture of the permit and the right to use said Transfer Station.

BE IT FURTHER ORDAINED that no hazardous waste shall be disposed of or dumped at the Hopkins County Transfer Station.

BE IT FURTHER ORDAINED that the small volume waste hauler shall pay to Hopkins County the sum of One Dollar (\$1.00) per month, per customer, as a service charge for the use of the Transfer Station provided the Hopkins County Fiscal Court agrees to assess this service charge or to grant the 109 Board authority to assess this service charge.

UPON MOTION by Hicklin, second by Ball, first reading was held and approved on the 30th day of June, 1992.


