 - 2. County will provide vision to all employees at a rate of \$5.78 per month. This includes a \$10 copay, exams and lenses every 12 months, frames every 24 months, with a frame and contact lens allowance of \$130.00. Employees may also buy additional coverage for family members.
 - 3. County paid \$25,000.00 Life and AD&D at a cost of \$.301 per \$1000.00 (Current cost for \$15,000.00 is \$.49 per \$1,000.00 so the total cost to the County will be almost the same.)
 - 4. Additional \$25 per month for those employees participating in Wellness.
 - 5. Continue to provide voluntary flexible spending accounts, dental and supplemental plans as in previous years.
 - 6. Renew our contract with KC Wellness at no increase over 2009.
 - 7. Look into allowing spouses to participate in Wellness. This could positively impact our health insurance premiums in future years.
