IN RE THE MATTER OF ACCEPTING A PORTION OF MUSKET LANE FROM ITS JUNCTION OF SQUIRE ROAD INTO THE COUNTY ROAD SYSTEM.

WHEREAS, the Hopkins County Fiscal Court on its own Petition has expressed the desire to bring into the County Road System a portion of a public road named Musket Lane, which is described with more particularity as 411 feet of Musket Lane off of Squire Road to the gas well, and whose width is thirty (30) feet.

WHEREAS, notice was published according to KRS 178.050 and notices were placed at three public places in the vicinity of said road.

WHEREAS, two viewers were appointed by the Fiscal Court together with the County Road Supervisor, who viewed the proposed road establishment and reported in writing to a public hearing held on June 23, 2005.

WHEREAS, their report stated that the advantages which will result to the individual and public are: "Will benefit the public and to the gas company."

WHEREAS, the Hopkins County Fiscal Court finds that establishment of the subject road is in the public interest in the following respects: (1) Benefit to the public and to the gas company.

NOW THEREFORE, BE IT ORDAINED by the Fiscal Court of Hopkins County that the above-described portion of the public road named Musket Lane shall be brought into the Hopkins County Road System.

This Ordinance shall become effective upon publication.
